1. General Anchor Communication

2. DSRIP Implementation

April DY10 Reporting Timeline

- **May 18, 2021** – HHSC will post the estimated IGT due for April reporting based on milestones and metrics reported as achieved. Final IGT due will be based on HHSC review and approval.
- **May 20, 2021, 5:00 pm** – Deadline for IGT Entities to approve and comment on their affiliated providers' April reported progress on metrics. Please note this process is optional.
- **June 1, 2021, 5:00 pm** – Due date for submitting any IGT changes in entities or proportion of IGT among entities using the IGT Entity Change Form.
- **June 14, 2021** – HHSC and the Centers for Medicare and Medicaid Services (CMS) will complete their review and approval of April DY10 reporting or request additional information (referred to as NMI) regarding the data reported.
- **June 16, 2021** – Estimated date for Provider Finance to send IGT notification.
- **July 6, 2021** – IGT settlement date for April reporting.
- **July 15, 2021, 11:59 pm** – Due date for providers to submit responses to HHSC requests for additional information (NMI requests) on April reporting submissions.
- **July 20, 2021** – April reporting DY10 DSRIP payments processed for transferring hospitals.
- **July 31, 2021** – April reporting DY8, DY9, and DY10 DSRIP payments for all providers and DY8 and DY9 DSRIP payments processed for providers that were not paid on July 20, 2021. There are separate transactions for each payment for each DY.
- **August 21, 2021** – HHSC and CMS will approve or deny the additional information submitted in response to HHSC comments on April reported milestone/metric achievement. Approved reporting will be included for payment in the next DSRIP payment period, estimated for January 2022.

Anchor Admin Cost Claiming

- Anchors should submit the cost claiming template, the percent-of-effort template, and the cost report certification to the program inbox (TXHealthcareTransformation@hhsc.state.tx.us) by Monday, 5/17/21. Please send any questions regarding anchor admin cost claiming or template issues to the program inbox by Friday, 5/14/21.
- Please note that HHSC does send confirmation emails when cost claiming submissions are received. If anchors do not receive a confirmation email within two business days of submitting cost claiming, please contact the program inbox again.

Compliance Monitoring

- MSLC has started reviewing Category 1, Category 2, and Category 3 open measures, as well as Category C measures newly selected for round 3. Please continue to encourage timely submission of documentation and have providers inform MSLC and HHSC of any difficulties as soon as possible.
- All compliance monitoring questions should be directed to the [HHSC compliance mailbox](#) and the [MSLC mailbox](#).
- HHSC is including the current compliance monitoring contact list for anchors' review. Anchors should update their region on one file and return it to the [HHSC compliance mailbox](#) by 6/4/21. Providers should e-mail the HHSC and MSLC mailboxes with future contact changes. HHSC will send the contact list out for review before each MSLC round.

DY11 Proposed Directed Payment Programs

The DSRIP Team is coordinating with our internal DPP partners on the development of the reporting timelines that we have discussed on previous anchor calls. At this point, reporting is still planned for October and April.

Applications for CHIRP, TIPPS, RAPPS and DPP BHS are closed. Provider Finance Department verified eligibility and will send estimated IGT later this month through Gov Delivery (sign up/update Gov Delivery Notices for the applicable DPP here: <https://service.govdelivery.com/accounts/TXHHSC/subscriber/new>).
