# Making Health Care Sustainable: Using Value Based-Care to Transform Patient Outcomes and Minimize Costs

#### Dr. Paul Hain

Dr. Paul D. Hain was recently named the North Texas Market President at Blue Cross and Blue Shield of Texas (BCBSTX). In this role, he works with sales and account management, network policy development, government and community relations as well as internal and external communications to support the company's interactions in the large and dynamic business community of the Dallas-Fort Worth area and throughout north Texas. He most recently served as the Chief Medical Officer for the North Texas Region.
