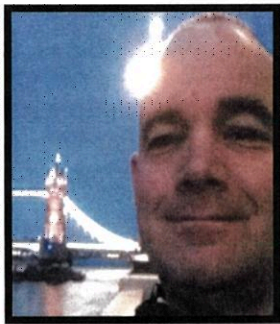

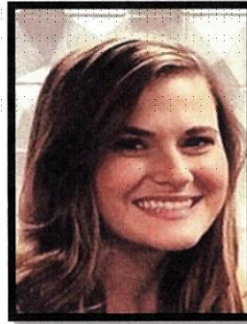
**Chad Anderson, MA,

Chad Anderson, MA, LPC Intern is a Clinical Manager with Metrocare Services in Dallas, Texas where he leads an ACT team at the Westmoreland Clinic. This multi-

disciplined team works with individuals that are high hospital utilizers and have been diagnosed with severe persistent mental illness. He is also a Crisis Evaluator for the Dallas County Medical Reserve and assists in disaster and public health emergencies such as the Christmas 2015 tornado response. He is an EMDR-trained therapist that specializes in PTSD and trauma recovery as well as substance abuse and forensic cases, and has studied Solution Focused Brief Therapy at the Brief Institute in London, UK. He has worked in the field of mental health for over 16 years, including 12 years in law enforcement, probation, and parole which is where he was originally trained in Motivational Interviewing. Chad now trains new clinical staff at Metrocare Services in MI, and uses MI on an almost daily basis including with his two teenage children.
